

OSHA Seeks Membership Nominations for Two OHS Advisory Groups—OSHA is seeking nominations for membership in two advisory groups: the National Advisory Committee on Occupational Safety and Health (NACOSH) and the Federal Advisory Council on Occupational Safety and Health (FACOSH). The agency is accepting nominations for six positions on NACOSH, a 12-member committee that advises the secretaries of labor and health and human services on regulations, research, compliance assistance, enforcement, and other issues related to the Occupational Safety and Health

Act of 1970. The available positions include two public representatives and one representative each from management, labor, occupational safety, and occupational health. According to OSHA, committee members serve a two-year term and may be appointed to successive terms. Nomination deadline: March 22, 2016.

OSHA seeks nominations for three labor and three management representatives to serve three-year terms on FACOSH, a 16-member council that advises the secretary of labor on the occupational safety and health of federal employees, including how to reduce injuries and illnesses and how to encourage federal departments and agencies to establish and maintain effective OHS programs. The new members would begin their terms on January 1, 2017. Nomination deadline: April 29, 2016.

NIOSH Study Illustrates Scope of Illness Caused by Two Common Herbicides-New NIOSH research indicates that, compared to other pesticides, a majority of herbiciderelated deaths in the U.S. are caused by the common herbicides paraguat and diquat. Agency researchers reviewed combined data from 1998 to 2011 using three sources-NIOSH's Sentinel Event Notification System for Occupational Risks (SENSOR)-Pesticides Program, the California Department of Pesticide Regulation Pesticide Illness Surveillance Program, and the EPA Office of Pesticide Programs' Incident Data System-in order to describe the scope of illness associated with the use of paraquat and diquat in the U.S. According to NIOSH, this study is the first to examine the extent of illness caused by the two herbicides. MSHA Implements Second Phase of Respirable Dust Rule—On February 1, the Mine Safety and Health Administration (MSHA) announced the implementation of Phase II of the agency's respirable coal mine dust rule. The final rule, which went into effect August 1, 2014, is intended to prevent black lung disease among coal miners due to exposure to coal mine dust.

Phase II of the rule requires underground coal mine operators to use continuous personal dust monitors (CPDMs) to measure dust levels in real time and monitor underground coal mine occupations exposed to the highest respirable dust concentrations, including all miners with signs of black lung. Operators must also collect an increased number of respirable coal mine dust samples and notify miners more quickly about the results of sampling. According to MSHA's press release, CPDM sampling results must be posted within 12 hours of

the sampled shift and miners with evidence of black lung should be notified within the first hour of their next work shift. The rule is being implemented in three phrases, with the third and final phase beginning in August 2016. For more information, visit MSHA's website.

Occupational Alliance for Risk Science (OARS)-The Occupational Alliance for Risk Science (OARS) provides a forum for information exchange about exposure guidance for chemical stressors, methods for improving occupational risk assessments, and training opportunities. The OARS serves as the home of exposure guide values, and related guideline documents, for chemical stressors. These guide values and supporting documentation related to worker and community exposure levels for chemical and physical agents and stressors are published by the OARS. OARS is managed by the Toxicology Excellence for Risk Assessment (TERA).

Putting an Ear to the Ground: NIOSH Study looks at Prevalence of Hearing Difficulty and Tinnitus among Workers-A new study from the National Institute for Occupational Safety and Health (NIOSH) examines hearing difficulty and tinnitus as two potentially debilitating physical conditions that are prevalent in the United States, especially among workers occupationally-exposed to noise. Data from the 2007 National Health Interview Survey (NHIS), a collection of detailed self-report information on hearing difficulty, tinnitus, and exposures to occupational noise, were examined. Hearing conditions were compared among workers with and without occupational noise exposure. and across industries and occupations. The study was published by the American Journal of Industrial Medicine last week.

# Oil and Gas Workers Suffering Hearing Loss at Double the Rate of Other Noisy Industries—

Source: CBCNews, British Columbia-Drilling and pipeline work is noisy business and according to a new report it's taking an alarming toll on the hearing of workers in B.C.'s gas and oil industry.

In a bulletin <u>WorkSafeBC</u> says those oil and gas patch workers are experiencing noise-induced hearing loss at a rate of 33 per cent, over twice the rate of workers in other noisy jobs. The report is based on tests conducted in 2014 and notes that young workers are most likely to forego hearing protection devices entirely, with 27 per cent of those under 21 reporting they didn't use hearing protection. More Evidence That 'BPA-free' Plastic May Still Pose Risk-By Rachel Feltman; Source: The Washington Post. Most folks have heard of Bisphenol A, or BPA, a chemical found in many plastics and in the epoxy resins used to coat metal cans. Some research has linked the chemical compound to cancer, infertility, asthma, heart disease, developmental disorders and other health problems. As a result, many manufacturers have removed it from their products. But a new study adds to a growing body of evidence that one common alternative could be just as problematic. The latest study, published recently in the journal Endocrinology, compared the effects of BPA on zebrafish embryos with the effects of Bisphenol S (BPS), a common alternative used in some (though not all) plastics labeled "BPA-free." The American Chemistry Council has previously expressed skepticism over BPA experiments using zebrafish, arguing that humans are only exposed to trace amounts of the chemicals through their diet and that these compounds don't accumulate in the body. NYU Research: Secondhand Smoke Hazardous to Hookah Bar Workers—According to the study, Secondhand Hookah Smoke: An Occupational Hazard for Hookah Bar Employees, led by researchers at New York University's College of Global Public Health (CGPH) and Langone Medical Center, workers at New York City hookah bars are inhaling hazardous levels of carbon monoxide and nicotine while at work, signaling yet another breach by their employers of New York City's anti-smoking bylaws. The finding of the study was published online in Tobacco Control.
