• The Standards Board was created by the Legislature in 1973, and is the only agency in the state authorized to adopt, amend or repeal occupational safety and health standards or orders.

Mission

• The mission of the Occupational Safety and Health Standards Board is to promote, adopt, and maintain reasonable and enforceable standards that will ensure a safe and healthful workplace for California workers.

 In addition to ensuring California's protections are at least as effective as Federal OSHA, the Standards Board also maintains standards for certain areas not covered by federal standards or enforcement. These latter standards apply to elevators, aerial passenger tramways, amusement rides, pressure vessels, and mine safety training. The Board does not engage in enforcement activities, such as interpreting standards, investigating incidents or complaints, training, levying fines, or issuing elevator permits. Those are the duties of the Division of Occupational Safety and Health (Cal/OSHA). Prioritization Method for Rulemaking Projects

- H= High
- S= Significant
- M=Moderate
- L=Lesser

Prioritization ranking for each rulemaking project set by the Standards Board's Principal Safety Engineer in consultation with the senior engineers and Executive Officer.

BASED ON 7 CRITERIA

- The likelihood that injury or illness will occur if the regulatory change is not made;
- The severity of the injury that would most likely occur if the regulatory change is not made;
- The type of injury or illness that would most likely occur if the change is not made;
- The approximate size of the population that would be affected by the change;
- Emergence of new technology or work practice that is inconsistent with or unanticipated by existing regulations;
- Quality of employee training and supervision for the affected line of work;
- Quality of existing regulations for the topic-whether the regulations are outdated, whether they are safeguarding workers as intended, whether they are overprotective, impossible to comply with, enforce or are unclear.


