**RE: Request for amendment to S.B. 774 – Specifying a Certified Industrial Hygienist be a member of the California Toxic Substances Board**

Dear Senator Leyva,

On behalf of the California Industrial Hygiene Council (CIHC), the American Industrial Hygiene Association® (AIHA), and AIHA's California Local Sections, I write to request that you amend Article 2, Section 24711 of Senate Bill 774 "Hazardous substances: California Toxic Substances Board" to require that one of the members of the California Toxic Substances Board, which would be created by this bill, would be a Certified Industrial Hygienist (CIH). As currently written, the bill states that one member of the board shall be "an environmental scientist qualified in the fields of toxicology, chemistry, geology, industrial hygiene, or engineering specific to the statutory responsibilities of the board."

A CIH is an individual who has met the requirements for education and experience as set forth by the American Board of Industrial Hygiene, and who through successful completion of the required examination, has demonstrated an acceptable level of skills and knowledge in a number of different areas, including, but not limited to: analytical chemistry, health risk analysis and hazard communication, toxicology, biohazards, and the practice of industrial hygiene.

Because CIHs carry a high level of distinction within the occupational and environmental health and safety professions, and their areas of expertise are fully in line with the proposed work of the California Toxic Substances Board, we strongly feel that the State of California and its 39 million residents would greatly benefit from specifying a CIH as a required board member.

With the addition of such an amendment, CIHC, AIHA, and AIHA's California Local Sections would all support the approval of S.B. 774 by the Environmental Quality Committee, and hope to see the bill enacted into law before the State Legislature adjourns this year.
